

### JIM JOEL'S LEGACY

Jim Joel was an outstandingly successful racehorse owner and breeder, winning the Derby on three occasions. He also won the Grand National in 1987. Shortly before he died in 1992, Jim Joel established a charitable foundation, The Childwick Trust. Thanks to the generosity of this Trust, the National Horseracing Museum has received a donation enabling us to set up the Jim Joel Legacy Scheme in recognition of Mr Joel's contribution to UK racing. Leaving a legacy to the National Horseracing Museum acknowledges the enjoyment the museum provides for so many and makes a lasting difference to the future of the collection.

### LEAVING A BEQUEST TO THE MUSEUM

There are three ways you can benefit the Museum in your will. You can leave a residual legacy; you can leave a pecuniary legacy for a sum of money; or you can leave a bequest of a specific item for the Museum's collection.

### Your Legacy could be used towards:

- £10,000 Funding a trainee Curator for 6 months
- £15,000 Funding our primary schools programme for a year
- £20,000 Funding the conservation of a painting
- £150,000 Supporting the education and community programme for three years
- £300,000 Refurbishing a gallery



The National Horseracing Museum is located in the historic heart of Newmarket, the UK's racing capital. It includes Palace House, the last surviving remnants of Charles II's palace, the Grade II listed Trainer's House, the King's Yard, the Rothschild Yard, an Olympic-sized arena, a working blacksmith's forge and paddocks.

The historic buildings present a beautiful setting for a collection reflecting the fascinating history and science of horseracing from its earliest origins to the present day. Palace House is home to the British Sporting Art Trust's unique collection.

The Rothschild Yard is home to the Retraining of Racehorses charity (RoR), enabling visitors to meet former racehorses being trained for life beyond the track.

The world around us is changing fast and we cannot predict what the future holds for the National Horseracing Museum. One thing is certain; we need to take action today to ensure that future generations can enjoy it forever.

## HOW TO LEAVE A WILL

### **TYPES OF DONATION:**

- (1) A residuary gift is a share of your estate after all other commitments have been settled.
- (2) A pecuniary gift is a donation of a sum of money eg: £1,000
- (3) Unrestricted gifts specific to the National Horseracing Museum are particularly valuable as they enable the Museum to use your donation where the need is greatest.

Alternatively, you can support a particular area of the work that is important to you. Whilst it is very simple to leave something in your will, we recommend that you consult a solicitor or professional advisor.
